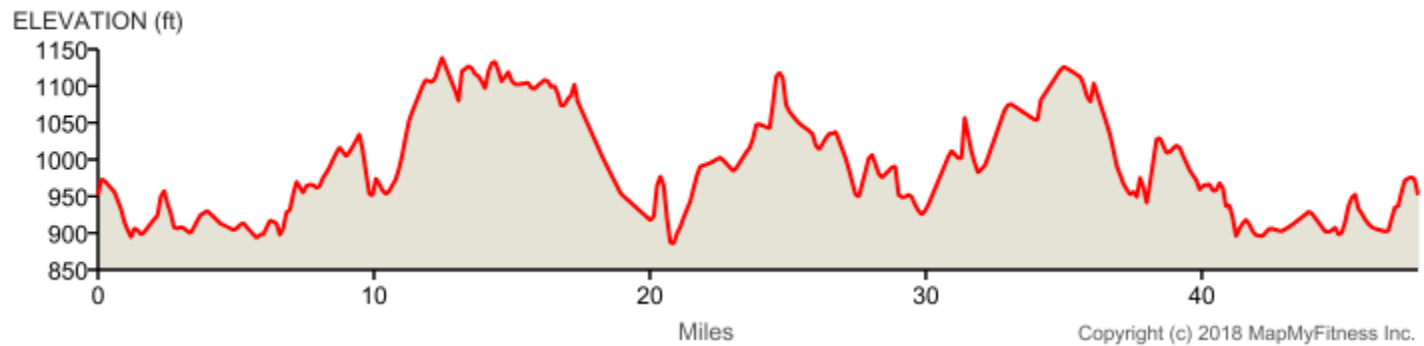
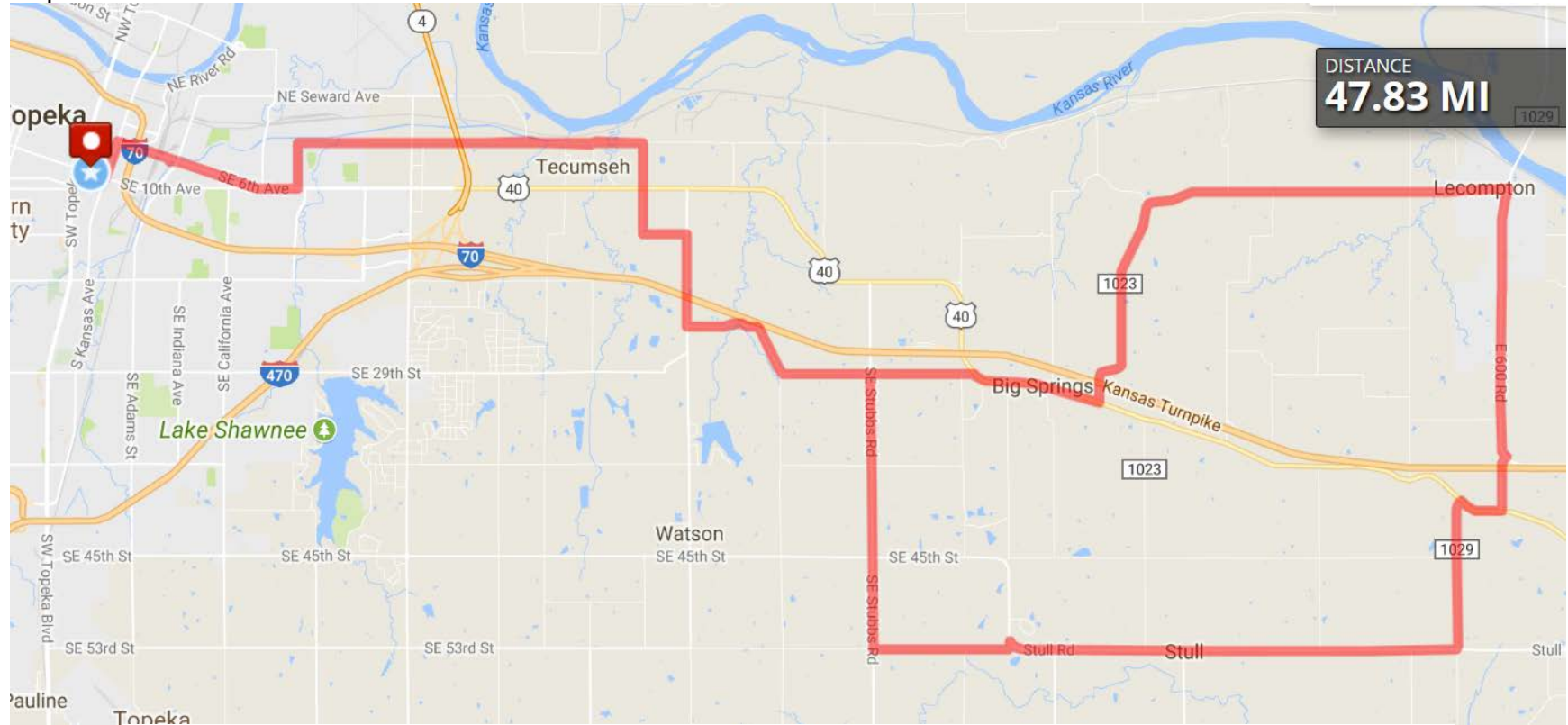


Capitol Classic – Medium Route



Medium Route

Take 10th street east to Kansas Ave. (turn left) onto Kansas Ave.

Take Kansas Ave. to 6th St. (TURN RIGHT) onto 6th St.

Take 6th St. to Tefft St. (TURN LEFT) onto Tefft St.

Take Tefft St. to 2nd St. (Turn Right) onto 2nd St.

Take 2nd St. to Dupont Rd. (turn Right) onto Dupont Rd.

Take Dupont Rd. across Highway 40 to 10th St.(Turn Left) onto 10th St.

Take 10th St to Shawnee Heights Rd. (Turn Right) onto Shawnee Heights Rd.

Take Shawnee Heights Rd to Ward Rd . (Turn Left) onto Ward Rd.

Take Ward Rd. to 29th St. At this point there will be a Y in the Rd. (Turn Left) onto 29th St.

Your **Sag** will Be at 29th and Stubbs Rd.

Get back on 29th St. and head east on 29th St. to 40 Highway.

(Turn Right) onto 40 highway

Take 40 highway to 1023 rd (Turn Left) onto 1023 rd . 1023 turns into N 2100 rd. Take N2100 Rd into Lecompton.

N 2100 Rd to Halderman St. (Turn Left) onto Halderman St. in about 100 yards (TURN RIGHT) into the Museum Entrance for the **2nd Sag Stop**.

Leave the museum as you came in except (TURN LEFT).

At N 2100 rd (TURN LEFT) onto N2100 rd

Take N 2100 Rd to 1029/438 or farmers highway as most of us call it. (TURN RIGHT) onto 1029/ 438 You will be heading south.

Take 1029/438 until you come to a Y in the road. (TURN RIGHT) onto 1029.

**** If you go left you will curve east and climb a hill. Berry Plastics will be on your left. YOU HAVE MISSED YOUR TURN AND HAVE GONE THE WRONG WAY. Turn around.**

1029 to Highway 40 (TURN RIGHT) onto highway 40.

Take highway 40 about 200 yards. (TURN LEFT) onto 1029 rd again.

Take 1029 rd to 442/ 45th st. (TURN RIGHT) onto 442/45th st.

Take 442/45st to Stubbs Rd. (TURN RIGHT) onto Stubbs.

IF YOU ARE DOING THE MEDIUM ROUTE DO NOT TURN LEFT AT THE TOWN OF STULL.

Stubbs to 29th St. (TURN LEFT) onto 29th St. The last **Sag** is on your Left.

Return back to the Judicial Center

Head West on 29th to Ward Rd. (Turn Right) onto ward Rd.

Ward Rd to Shawnee heights Rd (Turn Right) onto Shawnee Heights Rd.

Shawnee Heights Rd. to 10th St. (Turn Left) onto 10th St.

10th St. to Dupont Rd. (Turn Right) onto Dupont Rd.

Dupont Rd. To 2nd St. (Turn Left) on 2nd St.

2nd St. To Tefft St. (Turn Left) onto Tefft St.

Tefft St. To 6th St. (Turn Right) onto 6th St.

6th St. To Kansas Ave (Turn Left) onto Kansas Ave.

Kansas Ave. to 10th St. (Turn Right) onto 10th St.
